**PUBLIC NOTICE**

**FORMAL CASE NO. 1160, IN THE MATTER OF THE DEVELOPMENT OF METRICS FOR ELECTRIC COMPANY AND GAS COMPANY ENERGY EFFICIENCY AND DEMAND RESPONSE PROGRAMS PURSUANT TO SECTION 201(B) OF THE CLEAN ENERGY DC OMNIBUS AMENDMENT ACT OF 2018,**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that, on August 2, 2021, the Potomac Electric Power Company (“Pepco” or “Company”) filed the Company’s Three-Year Energy Efficiency and Demand Response Program (“EEDR Program”) for approval pursuant to Section 201(b) of the CleanEnergy DC Omnibus Amendment Act of 2018.<sup>1</sup> Pepco seeks to implement its EEDR Program beginning January 1, 2022, through December 31, 2024. The proposed EEDR Program offerings include: (1) Residential EE Portfolio; (2) low-and moderate-income (“LMI”) Home Energy Programs (customer segment targeted); (3) Non-Residential “Commercial” Programs; (4) Demand Response Programs; and (5) Pilot Programs.

2. By this Notice, all persons interested in commenting on Pepco’s proposed EEDR Program may submit written comments and reply comments not later than 45 and 60 days, after the issuance of this Notice.
