RE: CESSATION OF SERVICE AND VOLUNTARY SURRENDER OF ELECTRICITY SUPPLIER/BROKER LICENSE

Per your request, please find the information below related to the cessation of business in Washington, D.C.:

(1) Written notice to the Commission and to the Licensee's Customers at least sixty (60) days prior to the Licensee's intention to cease providing electricity service to its Customers. The notice shall state that the Licensee has informed its Customers of the choice to revert to the default service provider or to another electricity supplier;

This letter will serve as formal and final notice that Utility Savings Solutions LLC desires to terminate and surrender its license in the District of Columbia effective immediately. There are no clients or customers in the District of Columbia to notify as we have none.

(2) The Licensee shall provide to the Commission an example or copy of the notice it provided to its customers. Upon receipt of such notice, the Commission may order the Licensee to provide such further notice to its Customers or to the public as the Commission deems necessary, and/or take such other action that the Commission deems appropriate.

As we have no current or past clients to notify of the cessation of business, there is no one to notify or provide a notice to.

(3) The formal case number, order number, and date of license approval; The number of customers the Licensee serves and the type of service the Licensee provides;

(4) The date on which the Licensee seeks to cease providing service to customers and end its business operations; District of Columbia Municipal Regulations: CHAPTER 46: LICENSURE OF ELECTRICITY SUPPLIERS

It is our desire to cancel the certificate of registration as soon as possible at the earliest possible date.

(5) A statement addressing whether the Licensee owes any outstanding fees and assessments to the Commission and OPC, or taxes to the District of Columbia Government (District Government). If the response is in the affirmative, the application must reflect the amounts owed and whether the amounts are owed to the Commission, OPC, the District Government, or all. If any amounts are owed, either to the Commission, OPC, the District Government, or all, the application must address whether the surrendering Licensee has a payment plan in place and, if in the affirmative, include a description of the plan;

Utility Savings Solutions owes nothing in arrearages, fees, or taxes.


(6) A statement addressing the existence of any outstanding consumer complaints filed against the surrendering Licensee with the Commission, OPC, or the District Government. If in the affirmative, the application must describe the nature of the complaint, whether it has been resolved and if not, describe whether any resolution of the complaint is forthcoming; and

There are no outstanding consumer complaints or concerns related to Utility Savings Solutions in the District of Columbia

(7) A sworn affidavit from an officer or agent of the surrendering Licensee attesting to the accuracy and veracity of the application.

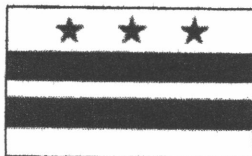
