Dear Chair Thompson, Commissioner Beverly, and Commissioner Trabue:

The undersigned commend the DC Public Service Commission for doing the right thing by rejecting Washington Gas Light's irresponsible \$672 million gas pipeline replacement program, Project Pipes 3, in June of this year. We were heartened that the Commission recognized that this exorbitantly expensive and unnecessary program would have raised customer rates, put public health at risk, and contradicted the District's own climate goals.

Now, WGL has submitted a new pipe replacement application, which they have rebranded as District Safe. Despite the name change, District Safe is simply Project Pipes 3 dressed in a new outfit, seeking \$215 million in immediate spending on what will necessarily become stranded assets. Like PROJECTpipes, the proposal asks the Commission to approve WGL's business-as-usual approach and put District ratepayers on the hook for billions of dollars to prop up the broken gas system over the next 40 years. However, we know every aspect of WGL's business is polluting the air we breathe, endangering the health and safety of DC residents, and contributing to climate change.

A new <u>report</u> from PSE Healthy Energy found DC ranked in the top 20 cities nationwide for the number of emergency gas leaks, with firefighters responding to 944 leaks in 2018 alone. In 2022, neighborhood researchers found nearly 400 active methane gas leaks across all eight wards of DC. According to new <u>data</u>, "explosive" gas leaks increased by 40% from 2014 to 2022. Please do not believe WGL when they say replacement of their vintage material is the most cost-effective and safest path forward, especially using a predictive model rather than prioritizing existing leaks. We also have data that show that WGL's system is responsible for nearly a quarter (22%) of all greenhouse gas emissions in the District, polluting our homes and leaking climate-warming methane gas directly into the atmosphere. The District Department of Energy and Environment's latest <u>emissions inventory</u> from 2021 indicates that a staggering 71% of DC's emissions come from buildings—emissions only made possible by WGL supplying dirty fossil gas. Residents just experienced <u>the hottest summer to date</u>, and future generations cannot afford to remain tied to

methane gas.

Rather than throw hard-earned ratepayer money at a gas system that is dangerous, pollutes our air, raises energy bills, and perpetuates the climate crisis, the Commission must fulfill its statutory mandate to regulate in a manner that accounts for "effects on global climate change and the District's public climate commitments" and direct a transition to net zero emission buildings in the District. Current DC law and public policy are premised on reducing emissions as quickly as possible, and the city is committed to achieving those reductions through electrification—a path supported by international and national scientific consensus. Transitioning DC's communities toward modern all-electric homes can deliver cleaner air across the city. This will help align the District's law and public policy with equitable approaches to redress a history of environmental racism and cumulative environmental impacts. The Commission cannot undertake what is needed to meet the climate crisis—or comply with District law and public

policy—by continuing merely to respond to utility filings like District Safe, which are all too often on the utility's terms and in the interests of maximizing shareholder profit over the public interest. By enacting and overseeing a holistic planning process—as is being done in other jurisdictions across the nation, and as was recommended by the DC Council in its February 8, 2024 letter—the Commission can ensure we move toward a future when residents and their loved ones can breathe clean air and live in safe, healthy communities, regardless of their zip code.

The DC Public Service Commission must <u>reject further spending</u> on unnecessary pipe replacements, as it did this past June, and move forward with comprehensive and proactive thermal energy planning.
