**Re: Formal Case No. 1171 – In the Matter of the Investigation into the Community Renewable Energy Facilities Practices in the District Bi-Weekly Report of Potomac Electric Power Company**

Dear Ms. Westbrook-Sedgwick:

Pursuant to Order 21908, in Formal Case 1171 issued on September 28, 2023, by the Public Service Commission for the District of Columbia (“Commission”), the Potomac Electric Power Company (“Pepco” or “Company”) was directed to submit Bi-Weekly Reports. This is Pepco’s Fifty-Fourth Bi-Weekly Report, regarding Community Renewable Energy Facilities (“CREFs”). Pepco completed the technological development phase for the permanent meter reading solution as of September 30, 2024. The permanent meter reading solution is operational and capable of reading meter generation data from CREF meters that have provided Pepco with necessary access to read their meters.

The Commission has requested that Pepco address the following topics in the Bi-Weekly Report:

- i. The number of CREF meters with cellular or wireless devices that Pepco is reading;
- ii. The Number of CREF meters being read by Pepco (including make and model and change from the prior week);
- iii. A list of CREF owners and/or Subscriber Organizations (“SO”) and the number of hours the SO has spent on meeting and site visits with Pepco; and
- iv. An Excel spreadsheet with location, meter make/model, whether Pepco has read the meter in the previous month or relied on default values, total number of subscribers, number of subscribers that received a monthly credit, and whether any unsubscribed energy Payment was made for the previous month.

**Section i. The number of CREF meters with cellular or wireless devices that Pepco is reading.**

Pepco is not currently reading any CREFs generation data via cellular or wireless devices.

**Section ii. The number of CREF meters being read by Pepco.**

Pepco completed the implementation of its permanent meter reading solution that can read CREFs generation meters as of September 30, 2024. Please note, not all CREF locations have provided Pepco with access to read their generation data to date and Pepco continues to utilize estimates for CREFs with meters that are unreadable as ordered by the Commission.<sup>1</sup>

Pepco was able to download actual generation data for 309 CREF meters for the current billing period which is reflected in the CREF Meter Status document. Pepco is using System Sized Estimates (PV Watts) for 62 meters. These values are used for CREF meters that the Company is not currently obtaining a generation reading. In addition, there are 0 CREFs that were offline for the billing period. Pepco has provided notices to these locations based on our records to inform them of the CREF's status.

**Section iii. and iv. Hours CREFs have spent on meetings/removal of meters and Spreadsheet with unsubscribed energy payments and subscriber credits.**

Attached are updates to the documents that provide the information requested in the Commission's Order. The attachments are as follows:

1. **Subscriber Organization Meetings** – Attachment 1 provides Pepco's assessment of the time CREFs/Subscriber Organizations have engaged to date with Pepco for meetings. The tab provides dates and durations by CREFs/Subscriber Organizations. Pepco compiled this information by reviewing the scheduled meeting times on the calendar invite with the CREF/Subscriber Organizations—the actual meeting may have been longer or shorter.
2. **Subscriber Organization Engagement on Site** – Attachment 2 provides Pepco's assessment of the time CREFs/Subscriber Organizations have engaged to date with Pepco on site related to meter removals. The tab provides dates and durations by CREFs/Subscriber Organizations. Pepco compiled this information by reviewing the scheduled meeting times on the calendar invite with the CREF/Subscriber Organizations—the actual

meeting may have been longer or shorter. If an SO is not listed on this Attachment, then there was no engagement with the SO on site.

3. **CREF Meter Reading Status** – Attachment 3 provides the location, CREF meter make and model, whether the meter was read, or default value was used for the reporting period, total number of subscribers, and CREFs/Subscriber Organizations that received a monthly credit and any unsubscribed energy payments to date. The total number of subscribers are grouped by CREF owner in this Attachment. Note: there are some “unknown” values in the “Meter Model” column because Pepco has not received meter model information from those CREFs.

Based on the information Pepco is still reviewing the remaining CREFs to determine if they are American National Standards Institute (“ANSI”) 12.20 compliant. Pepco notes that it is seeking additional information on whether their meters meet the requirement in the regulations to produce interval data. Pepco will continue its communication attempts with these CREFs to obtain information on their meter models. As Pepco receives this information, it will provide updates in subsequent Reports.
