This letter is submitted on behalf of West Safety Communications Inc. ("Company") to notify the Commission that the Company has changed its name to Intrado Safety Communications, Inc. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company's name as "Intrado Safety Communications, Inc." and change the Company name in all Commission records. The Company was originally authorized to provide facilities-based and resold local exchange telecommunications services in the District of Columbia pursuant to authority granted in Case No. 892; Order 11841 under the name SCC Communications Corp. The certificate was transferred to Intrado Communications, Inc. in Order 12220 and in 2016 the Company name was changed to West Safety Communications Inc. (FC 892-2016-T-4547).

A copy of the Company's Certificate of Amended Registration on file with District of Columbia Department of Consumer and Regulatory Affairs is attached hereto as Exhibit A.

The Company has changed its name as part of a recent rebranding and marketing campaign by its ultimate parent company, Intrado Corporation f/k/a West Corporation. The Company's name change does not entail any restructuring, merger or other transaction impacting the corporate existence or management of the Company. Customer notice is not required because the Company does not currently have any customers in the District of Columbia.

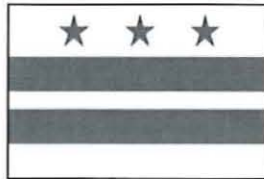
