Re: Formal Case No. 1150 – Benning Remediation

Dear Ms. Westbrook-Sedgwick:

On August 9, 2018, the Public Service Commission of the District of Columbia (Commission”) approved the Non-Unanimous Full Settlement Agreement (Settlement) in the above-captioned case in Order No. 19433. As part of the Settlement, Potomac Electric Power Company agreed to provide updates regarding its efforts to obtain insurance recovery for remediation costs associated with its Benning Road facility bi-annually, with the first update due on January 1, 2019. Specifically, Paragraph 14(d) of the Settlement provides:

Pepco will diligently pursue recovery of these RI costs and will report to the Commission bi-annually, beginning on January 1, 2019, on the status of the Company's efforts to obtain insurance recovery, until such time as the Company indicates, in a bi annual report, that all insurance recovery efforts have been exhausted.

Pepco is actively pursuing insurance recovery and has engaged a consulting group that specializes in claim strategy and reporting for the existing insurance claim. In addition, Pepco has provided additional updates to the appropriate insurers that have provided insurance to Pepco for the relevant timeframe, has held meetings with some insurers and is currently in the process of scheduling meetings with other insurers to discuss the current status of the claim and anticipated future costs. The Company will continue to file these updates according to the Settlement cited above and as future relevant information becomes available.
