This filing is being made in conjunction with the FCC's approval of AT&T's 214 filing, Application of AT&T for Discontinuance and Reclassification as Private Carriage, in Docket WC 19-323 (approved December 28, 2019). As a result of that application, AT&T now offers AT&T Dedicated Ethernet as private carriage. Through this filing, language is being added to the intrastate offering for AT&T Dedicated Ethernet to indicate that AT&T reserves the right to make individualized decisions regarding the provision of service to individual customers, and that AT&T may negotiate specific prices and terms for each individual customer.
