APPLICATION

BCM One, Inc. ("BCM One"), through its counsel and pursuant to Code of the District of Columbia §34-502, hereby requests approval from the District of Columbia Public Service Commission ("Commission") to obtain additional debt financing in the amount of \$200 million.

Pursuant to Rule 3501.12, Title 15 of the District of Columbia Municipal Regulations, 15 DCMR §3501.12, BCM One understands that this Application will be deemed approved upon filing with the Commission.

Applicant BCM One is a corporation duly organized and incorporated under the laws of the State of New York. BCM One was issued a Certificate of Convenience and Necessity to provide competitive local exchange carrier and interexchange carrier telecommunications services in a decision in Formal Case TA-04-8-5 on September 8, 2004. The principal office of BCM One is located at 295 Madison Avenue, 5th Floor, New York, New York 10017. The telephone number of BCM One is (888) 543-2000.

BCM One Group Holdings, Inc., the parent corporation that wholly owns BCM One, proposes to obtain additional debt financing in the amount of \$100 million to continue to effect the acquisition of complementary entities to BCM One, either directly or through one or more

wholly-owned subsidiaries of BCM One Group Holdings, Inc. It is contemplated that such

additional indebtedness would be on similar terms and conditions as set forth in the initial

request for \$105 million of indebtedness filed with the Commission on December 11, 2018

(TA04-8-22); supplemental request for \$50 million of indebtedness filed with the Commission

on February 4, 2019 (TA04-8-23); and supplemental request for \$200 million of indebtedness

filed with the Commission on February 7, 2020 (TA04-8-24). BCM One is a co-borrower with

BCM One Group Holdings, Inc. and other entities held by BCM One Group Holdings, Inc.

Notification, therefore, is being provided to the Board regarding the additional debt. If any of

the complementary entities have certificates in the District of Columbia, BCM One will apply for

appropriate authority to acquire such entities.

Approval of the debt financing described above will serve the public interest in promoting

competition among telecommunications carriers. There will be no impact on customers related to

the debt financing to facilitate future transactions.
