I would appreciate your help in registering my solar system in my name. The system was owned by Carter Keithley at 2739 Unicorn Ln NW, Washington, DC 20015. The DC Certification number is DC-102500-SUN-1 The system was put into production on December 10, 2010.

My husband and I bought the home on March 29, 2019. The SRECs were pre-sold to the installer/aggregator Direct Energy Solar until November 30, 2020. I did not realize that I needed to do any registration changes until that ran out. Indeed, I did not know this until the GATS administrator sent me that information today. Now, it seems, I need to change the ownership in the registration with the city.

I don't know what you will need in order to update the ownership of this system. If you look on-line at the DC Tax records, for example, you'll see that we own the home. <https://mytax.dc.gov/>

Let me know what questions I may need to answer in order to get this done.
