Pursuant to 15 DCMR §2707.7, enclosed please find a copy of Verizon Washington, DC Inc.'s ("Verizon DC") Certification of Public Notice of Network Change under 47 C.F.R §51.329(a); Public Notice of Copper Retirement under 47 C.F.R §51.333; and Certification of Public Notice of Copper Retirement under 47 C.F.R §51.333 filed with the Federal Communications Commission today.

As a result of the District of Columbia Department of Transportation's ("DDOT") Benning Road Reconstruction and Streetcar Project ("Benning Road Project"), Verizon DC must remove communications facilities out of the DDOT rights-of-way along approximately two miles of Benning Road NE from Oklahoma Avenue NE to East Capitol Street in advance of construction in 2023. As part of this project, Verizon DC will retire all copper facilities in the Benning wire center on or after September 13, 2021. Verizon has deployed or plans to deploy its fiber-to-the-premises network in this wire center and intends to provide services over its fiber network infrastructure.

After the retirement of the copper facilities, Verizon will: (1) no longer offer services over copper facilities; (2) cease maintaining the copper facilities; and (3) remove those copper facilities require to be moved as a result of the Benning Road Project. To help ensure an orderly transition, Verizon may require customers and interconnecting entities to migrate services off of copper facilities well before the copper retirement implementation date. Verizon DC will provide the customer notices required by 15 DCMR 2707, and will provide a copy of those notices to the Commission and the Office of the People's Counsel according to the required schedule.

To the extent this copper retirement necessitates the discontinuance of any regulated local exchange services, Verizon DC will file an application for abandonment of service to the local exchange services market required by Section 2706 at least ninety (90) days before any such abandonment.

Pursuant to Sections 51.325 – 51.335 of the Commission's rules, Verizon hereby submits the attached: Certification of Public Notice of Network Change Under Rule 51.329(a); Public Notice of Copper Retirement Under Rule 51.333; and Certification of Public Notice of Copper Retirement Under Rule 51.333.

Specifically, Verizon is providing notification of the replacement of copper distribution and loop facilities at all remaining locations in the Benning wire center in Washington, DC. Upon completion, Verizon will provide services available over its fiber optic network.

The majority of customers served by copper at these locations purchase "plain old telephone service." Following transition to fiber, Verizon will continue to offer these customers the same POTS over fiber at the same price as they received on copper facilities, with no change in the underlying features and functionalities in their service.

There may be one or more obsolete, narrowband services (such as certain DSO level services) that are incompatible with or unavailable over fiber. If so, we will work closely with those customers to address their particular needs.
