Pursuant to Merger Commitment No. 10, AltaGas Ltd. ("AltaGas") hereby provides information regarding the contributions from AltaGas, Washington Gas Light Company, and their affiliates (collectively, the "Companies") to charitable organizations and for traditional local community support. In compliance with this commitment, the Companies have designed a program that provides at least \$1.2 million in charitable contributions and traditional local community support, per year, in the Greater Washington, D.C. metropolitan area, with at least \$210,000 of these contributions and support, per year, given to charities serving District of Columbia residents. A list of the Companies' contributions is attached, which reflects the merger commitment spend for CY 2023 and the Companies' compliance with this commitment. As Washington Gas previously advised the Public Service Commission of the District of Columbia, Washington Gas's Fiscal Year now corresponds with the Calendar Year and as such Washington Gas's records are maintained on a Calendar Year basis.

The Companies also confirm the annual contribution of \$250,000 to the AOBA Educational Foundation.
