
**VERIZON WASHINGTON, DC INC. MOTION TO FILE  
NOTIFICATION OF THE CLOSING OF AUTHORIZED PAYMENT LOCATIONS  
WITH THE COMMISSION OUT OF TIME**

Pursuant to Rule 105.8 of the Rules of Practice and Procedure of the Public Service commission of the District of Columbia (“Commission”), 15 D.C.M.R. § 105.8 (1998), Verizon Washington DC, Inc. ("Verizon DC") respectfully request that the Commission grant permission to file its Notification of the closing of Authorized Payment Locations (“APLs”) with the Commission out of time.

On July 26, 2018, a Commission Compliance Inspector notified Verizon DC of an APL that was not in compliance with Commission Oder 10811. In investigating the identified APL, Verizon DC discovered that the APL discontinued accepting payments without notifying Verizon DC’s APL vendor. As a result, Verizon DC did not become aware of the status of this APL in time to file a notice of closure within 5 business days.

Concurrent with this motion, Verizon DC filed the required notification and respectfully requests that the Commission accept this late filing.
