## B. REGULATIONS

- 9. The classification of residence or business service for Remote Call forwarding arrangements is determined by the class of service of the connecting telephone number.
- 10. Charges for calls from the originating service to a Remote Call Forwarding telephone number are the responsibility of the originating service, <sup>2</sup> Charges as specified in C. following for the forwarding of calls from the Remote Call Forwarding number to the connecting telephone number are the responsibility of the Remote Call Forwarding customer.
