On September 10, 2018, Compass Power, LLC ("Compass Power" or the "Applicant") filed an Application with the Public Service Commission of the District of Columbia ("Commission"), seeking a license to operate as a broker of electric services for customers in the District of Columbia ("District"). The Commission's rules under Chapter 46 of Title 15 of the District of Columbia Municipal Regulations requires electric suppliers seeking to provide services in the District to submit information in their application describing their experience, financial capabilities and stability as an electric service provider. Pursuant to those rules, the Commission may request additional information to ensure that the Applicant is satisfying the regulatory requirements. Accordingly, please submit the following: 2

- Pursuant to Chapter 46, 15-DCMR, a CPA opinion or Accountant's Compilation report to accompany the financial statements;
- Pursuant to Chapter 46, 15-DCMR, an Integrity Bond in the amount of \$10,000 to support the financial integrity of the Application; Do we need for just
- Pursuant to Chapter 46, 15-DCMR, the Applicant's bank statements for the preceding six months;
