The Tecpath T-1 provides customers with flexible, high capacity bandwidth for a flat monthly rate. The customer has the flexibility of choosing any combination of voice or data products, by channel, not exceeding either 960 Kbps or 1.54 Mbps. Each 1.54 Mbps T-1 has the capacity for 24 channels with each channel having a capacity of 64 Kbps of bandwidth.
