By this letter, Hospital Energy, LLC notifies the Public Service Commission of the District of Columbia as follows for the purposes of updating its license information:

1. On December 31, 2017, Hospital Energy, LLC, a Connecticut limited liability company solely owned by Mark Mininberg, merged with and into Mininberg, LLC, now known as Hospital Energy, LLC, a New Hampshire limited liability company also wholly owned by Mark Mininberg.
2. The merger resulted in Hospital Energy, LLC, the New Hampshire entity, assuming all of the obligations and assets of the Connecticut entity.
