APPLICATION OF TARIFF

This tariff sets forth the service offerings, rates, terms and conditions applicable to the furnishing of intrastate end-user local exchange communications services by ACN Communication Services, LLC, hereinafter referred to as the Company, to Customers within the District of Columbia. ACN's services are furnished subject to the availability of facilities and subject to the terms and conditions set forth herein.

All Services in this tariff are grandfathered and available to existing Customers at existing locations only. Moves, adds or changes are not available for existing services and services are not available for new installations.

This tariff is on file with the Public Service Commission of the District of Columbia. In addition, this tariff is available for review at the main office of ACN Communication Services, LLC at 1000 Progress Place, Concord, North Carolina 28025.

SECTION 5.0 – LOCAL EXCHANGE SERVICES

All Services in this Section are grandfathered and available to existing Customers at existing **(C)** locations only. Moves, adds or changes are not available for existing services and services are not available for new installations. **(C)**

5.1 General

Call Timing for Usage Sensitive Services 5.1.1

Where charges for a service are specified based on the duration of use, such as the duration of a telephone call, the following rules apply:

- Calls are measured in durational increments identified for each service. All calls 5.1.1 which are fractions of a measurement increment are rounded-up to the next whole unit.
- 5.1.2 Timing on completed calls begins when the call is answered by the called party. Answering is determined by hardware answer supervision in all cases where this signaling is provided by the terminating local carrier and any intermediate carrier(s).
- 5.1.3 Timing terminates on all calls when the calling party hangs up or the Company's network receives an off-hook signal from the terminating carrier.
- 5.1.4 Calls originating in one time period and terminating in another will be billed in proportion to the rates in effect during different segments of the call.
- 5.1.5 All times refer to local time.
