

Pursuant to 15 DCMR § 105.8 (1998), Washington Gas Light Company ("Washington Gas" or "Company") hereby submits this Motion to File Out of Time Washington Gas's Report on Non-Major Service Outage ("Motion"). In support of this Motion, Washington Gas states as follows:

Under Public Service Commission of the District of Columbia ("Commission") Order No. 15630 and Chapter 37, Section 3701.11 of the Commission regulations, Washington Gas is required to submit the above-mentioned report within ten (10) days from the date of repair/restoration completion or within three (3) weeks of the event occurrence, whichever comes first, or June 17, 2019.


